#### **Minutes of the meeting :**

##### **1. To discuss the Budget planning for the Academic year 2020-2021 of B.Design.**

Review of budget 2020-21 to be presented in finance committee for necessary changes and recommendation. Budget was reviewed by the LMC members. Fees for SNTD course and for Autonomous courses are informed to LMC. Fee structure is attached herewith for reference

##### **2. To discuss about the recommendation of new course and the additional post for teaching.**

Bournemouth University and Manchester University to be confirmed for association. This course is under association process with Pearson's. Dr. Manju Hundekar and Ms.



Garima Bhalla were finalized by LMC to travel to both universities in January 2020 or February 2020 for finalization of the MOU's. Only the Undergraduate Course of Fashion Design was to be associated with both the Universities. Undergraduate Course of Fashion Communication and The Post Graduate Course of Fashion Design and Merchandising needs to be associated with foreign universities and is expected to be done at the earliest. Till then SOFT cannot publish the Course names of these Universities or even Pearson's on website and social media. The scope of Admissions will be higher when these associations take place.

**3. To discuss about the collaborations and associations with International university.**

With the Reference to the Vision Document of School of Fashion Technology, International Tie-ups Stage 1 was presented in the front of the LMC. SOFT is looking forward to three options as Expansion program:

Option no. 1: Exclusive University Tie-up:

Potential Institutions: FIT New York, US, University of Arts London, UK i.e. London College of Fashion and Central Saint Martin's, London

Option no. 2: Extension Programs ( 2 Years at SOFT and 1 Year at Foreign University:

Potential Institutions: Modartech, Florence, Italy, ESMOD, Paris, France, Ryerson University, Canada and Shenker Institute, Israel

Option no. 3: Certification Equivalence given by Foreign Institution:

Potential Institutions: Modartech, Florence, Italy, Naba-Domus, Milan, Italy and Shenker Institute, Israel.

**4. To inform all the members about the students' performance in SNDT Yuva mahotsava.**

**5. To discuss about the Fashion show and college fest "Inspiro".**

Discussion regarding event flow, sanctioning of budget and pre-requisite of the same.




**6. To discuss about the participation of faculties in fashion colloquia, India fashion forum conference for the exposure.**
