Hence, it is suggested that the marks obtained by the candidates at Master's level, work experience, any other added relevant qualification (Degree / Diploma), any research work done earlier can be the criteria, in that order for deciding the rank. Orders were taken from Madam Vice-Chancellor for approving the above criteria.
